

WELCOME MOTORCYCLE STUDENTS

Congratulations on your decision to enroll in the Intermediate Motorcycle Class (IC). This course is designed for the Motorcycle Learner's Permit Operator with approximately 500 miles of riding experience on their current motorcycle. **GOOD clutch and throttle control is a MUST.** Regardless of the number of years of riding experience or the number of miles that you have ridden, you are certain to learn something new. Successful completion of this course *may* waive the SC Division of Motor Vehicle Motorcycle License Skills Test, however, it is not guaranteed. The rules and restrictions on the reverse side have been developed to protect your safety and to ensure that the course proceeds in a smooth fashion.

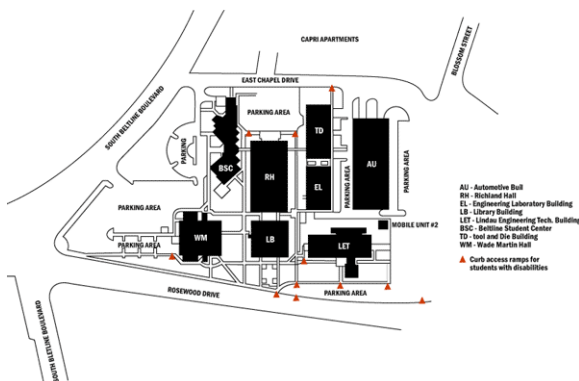

- **IC** students must have at least a Motorcycle Learner's Permit and be able to **demonstrate, to the instructor's satisfaction, adequate throttle and clutch control. Bring the learner's permit, motorcycle registration card and proof of insurance to class on Friday night.**
- Attendance in all class sessions is **MANDATORY.** The Intermediate Motorcycle Class is Friday from 6:00 p.m. to 10:00 p.m.; and Saturday or Sunday from 8 a.m. to 5 p.m. Class starts promptly. Weather or other factors may extend the scheduled ending time. If a double class is scheduled, all students are required to attend the Friday night session. Half of the class will ride on Saturday and the second half will ride on Sunday. Please **review** your confirmation notice to verify your schedule. Breaks will be scheduled hourly with a full hour for lunch.
- A **Waiver Form** must be completed and signed by all participants during the first session. Riders under the age of 18 but at least 15 years of age must have a parent or guardian sign the Waiver Form. Parents or guardians of riders under the age of 18 must come to the first class meeting. No one will be allowed on the motorcycle until a Waiver Form is signed.
- Workbooks will be provided to all students. **Please bring a pen, pencil and a note pad.**
- Whenever seated on a motorcycle, all students must wear the proper protective gear as explained on the back of this sheet. If you do not have a helmet, one can be provided. **Protective equipment is required Saturday and Sunday. Please obtain your equipment prior to class Friday night.**
- Students will ride their personal, street legal, fully registered motorcycle. It must pass a T-CLOCK inspection by the instructor. **Complete the attached form prior to your first class.** Please inspect and repair any defects prior to coming to the class. Any motorcycle with defects, adversely affecting the safe handling and control of the motorcycle, cannot be ridden in the class. Refer to the Motorcycle Owner's Manual for more information. Each student is responsible for the safe operation of his/her motorcycle.
- Students using a borrowed motorcycle must also bring a **completed and notarized Permission to Operate Form.** If your name is not on the registration card, it is a borrowed motorcycle for the purpose of this class.
- Optional equipment includes rain gear, sun block, and sunglasses. You may want to bring a small cooler with water or other liquids, but **ALCOHOLIC** beverages are strictly **PROHIBITED.** Range exercises may last beyond the lunch schedule, so consider bringing a snack.
- Motorcycle rider training is a demanding and physical activity. Please disclose any challenging disabilities or limitations per college policy. Students who fail to demonstrate a minimum level of safety may not be eligible to continue in the class. However, experience shows that the desire to ride combined with good clutch/throttle control is sufficient for most students to pass and receive a completion card.
- **You are required to pass a 50 question (multiple choice) knowledge assessment with an 80% or better grade and a riding skills assessment with no more than 25 penalty points to receive a completion card.** This class is not a substitute for Licensing Driver Education in accordance with SC GS: 56-1-175 and 56-1-180. This course does not meet the requirements for Defensive Driving Points Reduction IAW SC GS 56-1-770.
